



Microsoft says xCloud gaming not coming to iOS, blames Apple

San Francisco, Microsoft's xCloud streaming game service along with Xbox Game Pass will not arrive on the iOS devices on September 15 and the company has blamed Apple's App Store restrictions for this. Microsoft has accused Apple of treating gaming apps unfairly while allowing other media services to exist on the platform even when they include interactive content. According to The Verge, Microsoft was also only able to make one game "TestFlight, Halo: The Master Chief Collection" available and that was limited to 10,000 people and

each could only play one game. "Our Project xCloud preview TestFlight period has ended on iOS and we are focused on delivering cloud gaming as part of Xbox Game Pass Ultimate to Android customers beginning September 15," a Microsoft spokesperson said on Thursday. "Apple stands alone as the only general-purpose platform to deny consumers from cloud gaming and game subscription services like Xbox Game Pass," the spokesperson added. Apple earlier said these kinds of cloud gaming services are in violation of App Store guidelines. In a statement to

Business Insider, the iPhone maker said these gaming services cannot, in their current forms, ever exist on iOS. "Our customers enjoy great apps and games from millions of developers, and gaming services can absolutely launch on the App Store as long as they follow applicable to all developers, including submitting games individually for review, and appearing in charts and search," Apple said in a statement. Microsoft is all set to launch its much-anticipated game streaming service xCloud on September 15 for Android users in 22 countries.—IANS

Google launches Safe Folder in Files app to safeguard your data

New Delhi, As children share your devices for online classes and connect with friends in the social distancing times, Google has launched a new feature called Safe Folder in its Files app to help you keep personal content safe. "Safe Folder" is a secure, 4-digit PIN encrypted folder that protects important documents, images, videos and audio files from being opened or accessed by others. Google said that the folder is securely locked as soon as you switch away from the Files app, so none of its contents can be accessed when the app is in the background. "As a secu-

rety assurance, it will ask for your PIN again on reentry. Even people that don't share devices can benefit from keeping the most important files safe," the company said in a statement on Tuesday. Google launched the Files app in 2017 to help people who live in countries such as India, Nigeria and Brazil and often run out of space on a daily basis.

Equity indices in green ahead of RBI policy announcement

Mumbai, The key Indian equity indices traded on a positive note on Thursday ahead of the Reserve Bank of India's monetary policy announcement later in the day. Healthy buying was witnessed in IT and healthcare indices. Around 10.15 a.m., Sensex was trading at 37,875.68, higher by 212.35 points or 0.56 per cent from the previous close of 37,663.33. It opened at 37,946.80 and has so far touched a intra-day high of 37,976.72 and a low of 37,755.10.

Vitamin D twice a day may keep vertigo away

Seoul, Researchers have revealed that taking vitamin D and calcium twice a day may reduce your chances of getting vertigo again - a sudden internal or external spinning sensation, often triggered by moving your head too quickly. "Our study suggests that for people with benign paroxysmal positional vertigo, taking a supplement of vitamin D and calcium is a simple, low-risk way to prevent vertigo from recurring," said study researcher Ji-Soo Kim from Seoul National University in South Korea. "It is especially effective if you have low vitamin D levels to begin with," Kim wrote in a paper published in the journal Neurology.
