- 2) ensure that you have read and understood the contents of all the documents and information provided to you in relation to each Board of Directors/ Committee meetings and pursue such additional enquiries as you consider necessary and appropriate to be informed with respect to the Company's financial and operational performance;
- 3) Attend such other programmes / meetings as may be decided by the Board.



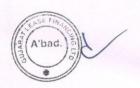
Remuneration and fees

Considering the financial position of the Company, you will not be paid any remuneration as an Independent Director, except following fees and reimbursement:

- a. Sitting Fees may be paid depending on the financial position of the Company but such fees shall not be higher than Rs. 1,00,000 for each meeting of the Board or any Committee thereof, attended by you and approved by the Board of Directors.
- b. You will be reimbursed for all the expenses incurred for attending any meeting of the Board or Committees thereof, and which may arise from performance of any special assignments given by the Board.

Other matters:

- You are required to comply with the Code of Conduct for Prevention of Insider Trading, Code of Business Conduct and other policies as may be applicable to you as a Director of the Company.
- 2. It is further brought to your notice that, in terms of section 2(60)(vi) of the Companies Act, 2013, an officer in default, inter alia, means:
 - every director, in respect of a contravention of any of the provisions of the Act, who is aware of such contravention by virtue of the receipt by him of any proceedings of the Board or participation in such proceedings without objecting to the same, or where such contravention had taken place with his consent or connivance;



3. The Independent Directors of any company, in terms of provisions of the Act are subject to various criteria pertaining to their independence. Hence your appointment as an Independent Director shall be subject to the adherence to the Independence criteria as per the provisions of the and SEBI (LODR) Regulations, 2015.
